## Justice Department Announces up to \$350M Settlement with Walgreens for Unlawful Opioid Prescriptions

On April 21, 2025, the Department of Justice, together with the Drug Enforcement Administration (DEA) and Department of Health and Human Services Office of Inspector General (HHS-OIG), announced a \$300 million settlement with Walgreens Boots Alliance, Walgreen Co., and various subsidiaries to resolve allegations that the national chain pharmacy illegally filled millions of invalid prescriptions for opioids and other controlled substances in violation of the Controlled Substances Act.

The company then sought payment for many of those invalid prescriptions by Medicare and other federal health care programs in violation of the False Claims Act.

The settlement amount is based on Walgreens's ability to pay. Walgreens will owe the United States an additional \$50 million if the company is sold, merged, or transferred prior to fiscal year 2032. <u>Read more</u> about the settlement.



#### DEA Takes Action Against Pharmacy that Could Not Account for Close to 50K Pills

Last month, DEA's Diversion Control Division signed an immediate suspension order (ISO) against Aspire RX in Philadelphia, Pennsylvania. The ISO alleges the pharmacy failed to account for more than 47,000 controlled substance tablets during an accountability audit (including 33,600 oxycodone 30 mg tablets, 4,981 oxycodone 15 mg tablets, 8,780 alprazolam tablets, and 169 promethazine with codeine bottles). DEA may issue an ISO and suspend a registration in cases where there is "imminent danger to the public health or safety." <u>21 U.S.C. 824(d)</u>.

In April, the DEA charged two ISOs and 13 Orders to Show Cause (OTSC).

#### **DEA Releases New Ketamine Resources**

DEA has a new webpage on the Diversion Control Division website dedicated to ketamine. Ketamine is a dissociative anesthetic that has some hallucinogenic effects. It distorts the perception of sight and sound and makes the user feel disconnected and not in control. It is referred to as a "dissociative anesthetic hallucinogen" because it makes patients feel detached from their pain and environment.
